# 2024 Reno Snaffle Bit Futurity Terms & Conditions

# THE FUTURITY

#### ELIGIBILITY

The Reno Snaffle Bit Futurity is open to 3-year-old horses, as of January 1 of the current show year, of all breeds, to be shown in three phases of futurity competition: Herd Work, Rein Work and Cow Work. Horses may be previously exhibited in a bridle, snaffle bit or hackamore, however, the horse may not have been shown in a bridle down the fence in any judged classes or events, with the exception of horse sales.

- All horses and riders must be named with first payment, and a copy of the horse's registration papers or NRCHA Grade Horse Competition License must be included.
- All owners and riders must be current members of the NRCHA.

# FUTURITY DIVISIONS, ENTRY FEES & PAYMENT SCHEDULE

Open Futurity Divisions: Open, Intermediate Open and Limited Open, Level 1 Open

- Rider will be automatically entered into all Open divisions for which they are eligible.
  - Open Divisions (Open, Intermediate Open, Limited Open) Entry Fee: \$2,850
- Level 1 Open will be offered as an additional jackpot for rider's who are eligible. Entries for this division are separate from the other three divisions, and will not be automatically entered. However, to compete in the Level 1 Open, you must also enter the Open Division.
  - Level 1 Open Jackpot (in addition to Open entry fee): \$350
- 2024 Payment Schedule:
  - \$500 due May 15
  - \$1,000 due July 1
  - \$1,350 due August 1
- Additional fees include: Cattle charge of \$450; Video Fee of \$65; and NRCHA Fee of \$10 per division. All additional fees are due by September 1, 2024. *Note: Office Fee is included in the Futurity Entry Fee.*

#### Non Pro Futurity Divisions: Non Pro, Intermediate Non Pro, Limited Non Pro, Level 1 Non Pro, Non Pro Boxing

- Rider will be automatically entered into all Non Pro divisions for which they are eligible.
  - Non Pro Divisons (Non Pro, Intermediate Non Pro, Limited Non Pro) Entry Fee: \$1,900
- Level 1 Non Pro: This division is a standalone division and may be entered separately, but will run concurrently with the Non Pro and Intermediate Non Pro divisions.
  - Level 1 Non Pro Entry Fee: \$1,000
- Non Pro Boxing is a standalone division. Herd Work and Rein Work may run concurrent with Non Pro.
  - Non Pro Boxing Entry Fee: \$1,000
- 2024 Payment Schedule for Non Pro, Intermediate Non Pro and Limited Non Pro Futurity Divisions:
  - \$600 due May 15
  - \$600 due July 1
  - \$700 due August 1
- 2024 Payment Schedule for Level 1 Non Pro & Non Pro Boxing Futurity Divisions:
  - \$500 due July 1
  - \$500 due August 1
- Additional fees include: Cattle charge of \$450; Video Fee of \$65; and NRCHA Fee of \$10 per division. All additional fees are due by September 1, 2024. *Note: Office Fee is included in the Futurity Entry Fee.*

# RENO SNAFFLE BIT SALES INCENTIVES FOR YEARLINGS AND 2-YEAR-OLDS

- Yearling and 2-year-olds sold in the Reno Snaffle Bit Sales are eligible to compete as 3-year-olds in the Reno Snaffle Bit Futurity for their Sale Incentive Purse. Horses must be paid into the incentive at the time of the sale.
- In order to be eligible for the purse, the incentive stays with the horse and is paid to the owner of the horse at the time of the show, regardless of who paid the incentive fee at the time of the sale.

#### FUTURITY DRAW DATE

 The draw date is Thursday, September 5, 2024. Draws will be posted on <u>www.renosnafflebitfuturity.com</u>.

#### FUTURITY EQUIPMENT

- Entries must be shown with both hands on the reins, except in the Herd Work, or to provide safety to the rider or adjust equipment.
- Entries must be shown in a standard headstall (browband, shaped-ear, or split ear), using a smooth snaffle bit, as described in Section 5.6 of the NRCHA Rulebook:
  - A D-ring or O-ring type snaffle bit, no larger than 4 inches in diameter on the inside of the ring.
  - Snaffle bits must have a broken, two-piece mouthpiece, being a minimum of 5/16-inch in diameter, measured 1-inch from the inside of the ring on the snaffle bit with a gradual decrease to center.
  - The mouthpiece should be round, oval or eggshaped, smooth and unwrapped metal.
  - It may be inlaide, but must be smooth.
  - Latex wrap is not acceptable.
  - These bits must be such that when the reins are pulled, no undue leverage is applied (i.e. the inside of the circumference of the ring must be free of rein, curb, or headstall attachments.
  - A leather or other woven material chin strap of any width is to be used. No iron, chain or other material may be used. Chin strap is allowed to include metal buckles and/or keepers on snaffle bits only.
  - Reins are to be attached above the chin strap.
  - Split reins must be used; no closed reins.
  - Rider or representative will drop the bridle to the designated backgate representative (bridle checker) for an equipment check. Failure to drop the bridle will result in a score of zero.
- One-hour prior to and during the start of the competition, all illegal equipment must be removed from the arena. This includes illegal equipment on turnback horses and herd holders.
- Size and design of horseshoes will be at the exhibitor's discretion.
- For all other equipment rules, refer to the NRCHA Rulebook.

# THE DERBY

#### ELIGIBILITY

The Reno Snaffle Bit Futurity's Derby is open to 4- and 5-yearold horses, as of January 1 of the current show year, of all breeds, to be shown in three phases of Derby competition: Herd Work, Rein Work and Cow Work. Horses must never have been shown in a bridle down the fence in any judged classes or events with the exception of horse sales.

All owners and riders must be current members of the NRCHA.

# DERBY DIVISIONS, ENTRY FEES & PAYMENT SCHEDULE

# Open Derby Divisions: Open, Intermediate Open and Limited Open, Level 1 Open

- Rider will be automatically entered into all Open divisions for which they are eligible.
  - Open Derby Divisions (Open, Intermediate Open, Limited Open) Entry Fee: \$1,930
- Level 1 Open Derby will be offered as an additional jackpot for rider's who are eligible. Entries for this division are separate from the other three divisions, and will not be automatically entered. However, to compete in the Level 1 Open, you must also enter the Open Division.
  - Level 1 Open Jackpot (in addition to Open entry fee): \$350
- 2024 Payment Schedule:
  - \$500 due May 15
  - \$715 due July 1
  - \$715 due August 1
- Additional fees include: Cattle charge of \$450; Video Fee of \$65; and NRCHA Fee of \$10. All additional fees are due by September 1, 2024. *Note: Office Fee is included in the Derby Entry Fee.*

#### Non Pro Derby Divisions: Non Pro, Intermediate Non Pro, Limited Non Pro, Level 1 Non Pro, Non Pro Boxing

- Rider will be automatically entered into all Non Pro divisions for which they are eligible..
  - Non Pro Divisons (Non Pro, Intermediate Non Pro, Limited Non Pro) Entry Fee: \$1,000

- Level 1 Non Pro: This division is a standalone division and may be entered separately, but will run concurrently with the Non Pro and Intermediate Non Pro divisions.
  - Level 1 Non Pro Entry Fee: \$1,000
- Non Pro Boxing is a standalone division. Herd Work and Rein Work may run concurrent with Non Pro.
  - Non Pro Boxing Entry Fee: \$550
- 2024 Payment Schedule for Non Pro, Intermediate Non Pro and Limited Non Pro Derby, & Level 1 Non Pro Derby Divisions:
  - \$500 due July 1
  - \$500 due August 1
- 2024 Payment Schedule for Non Pro Boxing Derby Divisions:
  - \$225 due July 1
  - \$225 due August 1
- Additional fees include: Cattle charge of \$450; Video Fee of \$65; and NRCHA Fee of \$10 per division. All additional fees are due by September 1, 2024. Note: Office Fee is included in the Derby Entry Fee.

#### DERBY DRAW DATE

 The draw date is Thursday, September 5, 2024. Draws will be posted on <u>www.renosnafflebitfuturity.com</u>.

#### DERBY EQUIPMENT

- Horses are to be shown in a snaffle bit, or a Hackamore, as described in Equipment Rule 5.5 of the NRCHA Rulebook. The same type of headgear (hackamore or snaffle) must be used throughout the event (herd, rein and cow work) on a horse once the competition has started.
- Entries must be shown with both hands on the reins, except in the Herd Work, or to provide safety to the rider or adjust equipment.
- Entries must be shown in a standard headstall (browband, shaped-ear, or split ear), using a smooth snaffle bit, as described in Section 5.6 of the NRCHA Rulebook:
  - A D-ring or O-ring type snaffle bit, no larger than 4 inches in diameter on the inside of the ring.
  - Snaffle bits must have a broken, two-piece mouthpiece, being a minimum of 5/16-inch in diameter, measured 1-inch from the inside of the ring on the snaffle bit with a gradual decrease to center.
  - The mouthpiece should be round, oval or eggshaped, smooth and unwrapped metal.

- It may be inlaide, but must be smooth.
- Latex wrap is not acceptable.
- These bits must be such that when the reins are pulled, no undue leverage is applied (i.e. the inside of the circumference of the ring must be free of rein, curb, or headstall attachments.
- A leather or other woven material chin strap of any width is to be used. No iron, chain or other material may be used. Chin strap is allowed to include metal buckles and/or keepers on snaffle bits only.
- Reins are to be attached above the chin strap.
- Split reins must be used; no closed reins.
- Rider or representative will drop the bridle to the designated backgate representative (bridle checker) for an equipment check. Failure to drop the bridle will result in a score of zero.
- One-hour prior to and during the start of the competition, all illegal equipment must be removed from the arena. This includes illegal equipment on turnback horses and herd holders.
- Size and design of horseshoes will be at the exhibitor's discretion.
- For all other equipment rules, refer to the NRCHA Rulebook.

### ADDITIONAL FUTURITY & DERBY ENTRY INFORMATION

#### SCRATCHES/REFUNDS

- Scratches made before September 1 will be fully refunded, with the exception of any late penalties paid.
- Scratches made after September 1 but BEFORE the Reno Snaffle Bit Futurity's Futurity/Derby draw will be refunded all entry money paid to-date, with the exception of the Office Fee, Cattle Fee, and any late penalties paid.
- Scratches made AFTER the Reno Snaffle Bit Futurity's Futurity/Derby draw will only receive a refund for the Video Fee.
- Horses scratched after the draw may only re-enter as a late entry, and will be placed in the draw according to NRCHA Rule 9.4.1.

#### **FUTURITY & DERBY LATE ENTRIES**

- *Prior to Draw:* Late entries will include the entry fee due at the time of entry, plus an additional late fee of \$25 per missed payment (maximum of \$75).
- After the Draw: Late entries will be accepted until noon the day before the competition division begins. Late entries will include the entry fee, plus an additional late fee of \$25 per missed payment (maximum of \$75). Entries received after the draw will be placed in the draw, once entries close, according to NRCHA Rule 9.4.1.

#### SUBSTITUTIONS

#### Horse Substitutions

- The substitute horse must be owned by the same person(s).
- The following items must be sent to the RSBF Show Secretary or presented to the Horse Show Office by noon the day before the entered division begins:
  - A veterinary certificate or statement stating why the entered horse will be unable to compete
  - A new entry form completed with the substitute horse's information
  - A copy of the new entry's registration papers or a NRCHA Grade Horse Competition License
  - A subsitution fee of 10 percent of the the total entry fee paid to date
- Substitutions that do not provide all items listed above will be considered a late entry and will be assessed late entry fees due at the time of entry.

#### **Rider Substitutions**

- Riders may be changed until the draw.
- Rider changes after the draw must be approved by the Show Committee.

# HORSE SHOW CLASSES

#### HORSE SHOW ENTRY FEES

 Horse show classes are listed on the Horse Show Class List included in this packet with corresponding entry fees and additional fees.

#### **DUE DATE & DRAW DATE**

- Horse show entries are due September 1, 2024.
- Horse show classes will be drawn on Saturday, September 7, 2024.

#### HORSE SHOW LATE ENTRIES

- A \$100 late fee will be applied to any entries received after the September 1 due date, with the exception of the Youth classes, which will be assessed a \$50 late fee.
- Any entries received after the draw date of September 8, 2024 will go at the beginning of the class.
- Late entries will close at 12 p.m. the day before the designated class is scheduled to run. Please visit the Show Office if entering at the show.

#### HORSE SHOW SCRATCHES/REFUNDS

- Scratches made before September 1 will be fully refunded.
- Scratches made after September 1 but **BEFORE** the Reno Snaffle Bit Futurity's Horse Show draw will be refunded entry fee, with the exception of the Office Fee, Cattle Fee, and any late penalties paid.
- Scratches made **AFTER** the Reno Snaffle Bit Futurity's Horse Show draw will only receive a refund for the Video Fee.
- Horses scratched after the draw may only re-enter as a late entry, and will be placed in the draw according to NRCHA Rule 9.4.1.

### **GENERAL INFORMATION**

- An owner may enter more than one horse.
- A rider may show more than one horse.
- A horse may only be entered one time in each horse show class, futurity or derby division:
  - Open divisions including Open, Intermediate Open and Limited Open, and Level 1 Open
  - Non Pro including Non Pro, Intermediate Non Pro, Limited Non Pro, and Level 1 Non Pro
  - Non Pro Boxing
- Prize money will be paid to the owner. Checks will not be released without Social Security/Tax Identification (TIN) numbers. *Futurity and Derby checks will be mailed within 30 days following the Reno Snaffle Bit Futurity.*
- The Show Committee reserves the right to accept or reject any entry. All decisions are final.
- The Reno Snaffle Bit Futurity reserves the right to cancel, transfer, or reschedule the Reno Snaffle Bit Futurity without notice and/or liability. In the event of cancellation, all entry fees paid to date will be refunded. Interest earned on the entries is the property of the Reno Snaffle Bit Futurity.

- All owners and riders must be current members of the NRCHA.
- NRCHA rules will apply, unless specifically noted.

#### **MOVE-IN DATE**

• Horses may start arriving at the Reno-Sparks Livestock Event Center beginning on Friday, September 6 at 12 p.m.

#### PAYMENT INFORMATION

- It is the owner's responsibility to make payments by the payment schedule due dates. RSBF is not responsible for entries or payments received late, and checks should be postmarked no later than the due date. Send guaranteed mail or USPS Priority through the post office to ensure delivery.
- Please make checks for entries and additional fees payable to "Reno Snaffle Bit Futurity."
- If residing out of the country, please send payment in U.S. dollars.
- Payments must be received or postmarked on or before the designated due date, or late penalties will be assessed. There will be no grace period.
- Payments returned due to insufficient funds will constitute an incomplete entry, and the responsible party will be subject to late fees upon re-entry, and for any bank fees associated with the transaction.

#### **CHANGE OF OWNERSHIP**

- If an entry changes ownership, the entry will retain eligibility by following these steps:
  - Notify the Show Secretary of the change in ownership, along with the intention of the new owner to assume the entry responsibilities.
  - Provide the Show Secretary with a copy of the corrected registration papers or NRCHA Grade Horse Competition License showing the new owner.
  - Payment of remaining entry fees when due.
- RSBF reserve the right to approve all ownership transfers.
- For ownership transfers on the show grounds, all horse owner transfers must be given to the Show Office. Please provide the original papers, breed association transfer form, and appropriate fees. The Show Office will mail the transfer to the breed association.

#### **STALLS, SHAVINGS & HAY**

- Stalls will be assigned on a first come-first served basis and must be pre-paid by September 1, 2024.
  - Stall fees in the permanent barns: \$275 each
  - Stall fees in Barn 1: \$225 each
- Stalls ordered after September 1, 2024 will be charged an additional \$100, and are not guaranteed location.
- A Stall Confirmation List will be posted on the Reno Snaffle Bit Futurity website within a week of move-in for exhibitors to verify stall count is correct. Please contact the Show Secretary with any changes or corrections.
- Shavings for stalls are not included in stall fees. Stalls will be provided with and automatically charged for four (4) bags of shavings at \$13.50 per bag. Tack stalls will not be provided with or charged for shavings.
- Additional shavings and alfalfa hay may be ordered throughout the show. Order forms will be available in the Show Office.
